Privacy

If released to government the information may be subject to consideration for release under the *Freedom of Information Act 1982 (Vic)*.

Terms and Conditions

Students from Australian Government and non-Government Schools. All sportspeople living with disability are eligible and encouraged to apply. Athletes must be competing in a peak body sanctioned national or international sporting event.

This may include:

- School Sport Australia Championships
- National Sporting Organisation (NSO) Championships
- Olympics / Paralympics

Applicants must:

- be enrolled at an Australian school;
- have sporting potential consistent with competing at state or national representative level;
- be 10 years or older;
- be an Australian citizen or permanent resident of Australia (within the meaning of the *Australian Citizenship Act 2007 (Cth)*);

- have financial circumstances that would preclude them from otherwise participating at representative level; and
- meet any SESF application deadlines. No late applications will be considered.

Families and students can re-apply each year, regardless of the outcome of the application the previous year.

Each recipient will receive an amount up to a maximum of \$1000.

Recipients must use all of the money awarded from the scholarship to fund their participation to the designated sporting event. Recipients may be asked to report to SESF on their expenditure of the money.

In consideration of SESF accepting your application you:

- (a) release and will release SESF from all Claims that you may have or may have had but for this release arising from or in connection with the Scholarship; and
- (b) indemnify and will keep indemnified SESF to the extent permitted by law in respect of any Claim by any person arising as a result of or in connection with the Scholarship.

Claim means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising including but not limited to negligence.

You will comply with any health-related directions issued by any government in respect to your participation in any event using Scholarship monies. You declare that you are medically and physically fit and able to participate in sporting activities. You are not and must not be a danger to yourself or to the health and safety of others.
